Statement of Cooperation

As I enroll my child as a student in Northern Michigan Christian Academy, I pledge my support for the spiritual, educational, and disciplinary program of the school, and although I may at some time disagree with a specific procedure or decision, I realize that the success of the training program I have chosen for my child depends greatly upon the overall support of parents by school officials.

Therefore, I will bring any complaints directly to the appropriate teacher or administrator without engaging in destructive verbal criticism of the school or its staff in the presence of my child or friends.

As much as possible, I plan to attend the special programs planned for parents this school year. I give permission for my child to participate in regular school activities, athletics, and school-sponsored trips, and I agree to hold harmless Northern Michigan Christian Academy. It is my desire and intention to work and sacrifice in order that this school year will offer my child the best possible opportunities for mental, spiritual, and emotional growth.

I understand that the school has full discretion in the classroom discipline of my child, which may include corporal punishment (spanking). However, I do understand the alternatives of choosing a suspension for my child or personally disciplining my child at the school or at home, in lieu of a spanking given by school staff. I understand that any personal discipline given by me as a parent should fully support the decisions and actions of the classroom teacher. If unacceptable behavior continues at school and is not resolved, I understand that my child will be suspended or, worse case scenario, expelled permanently from NMCA.
